- Shall NOT dry with a sticky or oily residue and must be resoil neutral. Should not contain d'limonene or any lauryl sulfate derivative.
- Have a pH between 4 and 9.
- Should NOT damage nylon face yarn or remove/mute color.
- Should not contain a bleaching agent.
- May not alter fiber color in any way.
- Must be used as a Prespray only, followed by a clear water rinse.
